TWENTY-FIRST CENTURY PARTNERS SYSTEM System Overview

The Twenty-First Century PARTNERS SYSTEM brings highly sophisticated computerized administration within reach of all hedge fund organizations whether large or small. It is written entirely in the language of the business and professional community. It can be used immediately for any type of hedge fund and requires no prior knowledge of computers.

The PARTNERS SYSTEM reduces the difficult tasks of hedge fund distributions and tax reporting. A variety of allocation formulas are available to make the distributions automatically. You can also define your own customized formulas for special allocations. The system prints IRS Form 1065 Schedule K and Schedule K-1 reports. The system also generates information for state tax returns. Both IRS facsimiles and IRS approved substitute schedules are available.

The PARTNERS SYSTEM simplifies the task of tracking each investor's capital account from escrow through termination. Quarterly and annual account statements may be printed for each investor showing the beginning and ending balances as well as any transaction activity such as investments, withdrawals and distribution payments. An investor phone directory may be printed showing the name, address and phone number of each investor in alphabetical order.

During the escrow period, the Partners System monitors investments to the hedge fund. The amount of interest earned by each investors is computed based on the deposit amount and date. Several reports are available including a Hedge Fund Offering Investments Report, Escrow Interest Report and a Blue Sky Report. The PARTNERS SYSTEM also generates Investor Welcome Letters, Escrow Confirmation Letters and Hedge Fund Certificates. If desired, escrow interest checks can be printed for each of the investors.

If hedge fund units are sold through brokers, the PARTNERS SYSTEM offers the capability of supporting their activity. The system computes brokerage commissions including wholesale fees, due diligence fees and broker sales fees. Each broker's name, address, phone and market territory are stored. Quarterly and annual reports may be mailed to the brokers showing the account status and yield by account for each of the investors that they brought into the hedge fund. Summary reports are available to analyze performance by marketing territory and individual broker sales representative. A broker sales rep directory listing is also available.

Hedge Fund distribution checks may be printed for five types of payments: quarterly distribution payment, annual distribution payment, special distribution payment, termination distribution payment and an escrow interest distribution payment. The checks may either be made out to the investor or to an optional check payee such as a trust fund and mailed directly to the bank/trustee for deposit. A Distribution Check Register Report may be printed for all distribution payments. A Distribution Check Reconciliation Report is also available for a range of check numbers corresponding to a bank statement.

System Overview

Mailing labels may be printed for six types of mailings: investor labels across all hedge funds, investor labels for one hedge fund, distribution check labels, duplicate statement labels, broker sales rep mailing labels and broker commission check labels. Duplicate investor statements may be mailed to the investor's accountant, attorney, bank or other designated person. Window envelopes may also be used with the investor statements, broker statements and distribution checks to facilitate the mailing process.

Many other management reports are available to provide a wealth of information on the hedge fund. Rather than printing voluminous reports, the information may be previewed on the computer's display screen. The PARTNERS SYSTEM provides easy to use menus and inquiry screens to access the information quickly.


